All entries must submit a current copy of horse registration papers and copy of owner/trainer/exhibitor AHA Competition Membership cards, or single Event Membership Fee of \$35 must be paid.

AHA MEMBERSHIP STATEMENT

EACH COMPETITOR (THIS INCLUDES AT LEAST ONE RECORDED OWNER AND ALL TRAINERS, DRIVERS, RIDERS, HALTER HANDLERS, COACHES AND THE PERSON(S) SIGNING THE ENTRY BLANK) IN AN ARABIAN HORSE ASSOCIATION RECOGNIZED ARABIAN DIVISION, AT THE TIME OF ENTRY INTO A COMPETITION, MUST SUBMIT A COPY OF A VALID AHA MEMBERSHIP/COMPETITION CARD, JOIN AHA OR PAY AN AHA SINGLE EVENT MEMBERSHIP FEE PER COMPETITOR.

WHEN AN AGENT SIGNS FOR THE OWNER AT AN AHA RECOGNIZED COMPETITION, BOTH THE OWNER AND AGENT MUST BE MEMBERS OF AHA OR PAY THE AHA SINGLE EVENT MEMBERSHIP.

SINGLE EVENT MEMBERSHIP IS NOT ACCEPTABLE AT AHA REGIONAL OR NATIONAL COMPETITIONS.

EXHIBITORS IN WALK-TROT CLASSES ARE EXEMPT FROM AHA MEMBERSHIP REQUIREMENTS AT QUALIFYING COMPETITIONS, BUT MUST HAVE AN AHA MEMBERSHIP WITH COMPETITION CARD AT AHA REGIONAL AND NATIONAL COMPETITIONS.

EXHIBITITORS IN LEAD LINE CLASSES OR PARENTS/GUARDIANS SIGNING FOR MINORS ARE EXEMPT FROM AHA MEMBERSHIP REQUIREMENTS. (BOD 5/12)

Classes with 1 entry may be combined when appropriate at discretion of show management.

TBA classes to be considered may be any ATR, JTR class from the AHA class list with the exception of Trail,

Cow classes, Over Fence classes, Dressage or Sport Horse classes.

Horses showing in Performance Horse Halter must be entered and shown in any performance class at THIS show. Failure to compete in a performance class will result in forfeiture of awards.

Horses may arrive at the Murieta Equine Complex showgrounds on Thursday January 13th, 2021. Stabling will be available by noon on Thursday for 3 night only. Horses that require a Monday night stay must make arrangements with MEC at an additional overnight charge. Arenas will be open for practice and warm up
